

In September 2022, the car met with an accident and **Nimal** had to use alternative transportation to go to work. Therefore, **Nimal** did not pay the agreed installments for 6 months as agreed. **Sri-Lak Enterprises** is keen on recovering the possession of the motor car and they have employed two people to bring back the car. Meanwhile, **Nimal** is trying to resell the vehicle to a third party, as the selling prices of the motor vehicles have gone up drastically.

You are required to:

(a) **Explain** the legal rights and duties of **Nimal** in this regard.

Question 03

Law of agency recognizes different forms of agency created by implied means. One way of creating an agency between a principal and an agent is by ratification. When an agent has acted outside the authority granted, the principal is not bound by the actions carried out by his agent. Question 04

Azar and **Ameer** started a partnership business, **A&A** to sell sports items for cricketers. They both worked together to develop their business which basically imports cricket items from India. However, **Azar** found that though **Ameer** has purchased cricket bats at a discounted price from **Bat-Man Ltd.** of India, he has sold it to the **A&A** business at the existing market price which is 40% higher than the price at which he bought them. **Ameer** earned a secret profit out of this transaction, and he did not share it with **Azar** as well.

You are required to:

(a) **Explain** the duties breached by **Ameer** as a partner.

- (b) **Explain** two(02) circumstances under which an unpaid seller is permitted to re-sale the goods. (04 marks)

Question 07

(A) **Mr. Ginikana**, a recently retired lawyer who lives in Colombo, decided to move to remote area in Monaragala. **Mr. Ginikana** will be moving to this new place at the end of 2023. Therefore, he will no longer need his car, a five year old Benz. On 11th Sunday of December 2022, he placed an advertisement in the notice board of court premises.

FOR SALE

Benz-1948 in excellent condition.

Will be sold to the first person who sends notice in writing that he wish to buy it for Rs. 3 Million to the following address: 666, Hulftsdorp, Colombo-12.

On 12th Monday morning, **Mr. Ginikana** rings **Ms. Kalpana**, a newly qualified lawyer and offers his car to her with the same details on the advertisement. On the same day, she posts a letter stating that she wants to buy **Mr. Ginikana's** car on next 16th Friday morning. This letter was reached to Colombo-12 address by 14th Wednesday.

On 12th Monday morning, when **Ms. Podimenike**, **Mr. Ginikana's** junior lawyer, saw the advertisement in the notice board and posted a postcard to **Mr. Ginikana** on the same day stating that she is willing to pay Rs. 3 million for the car. **Mr. Ginikana** received the postcard on 13th Tuesday.

On 13th Tuesday evening **Mr. Ginikana** went for a dinner with **Mr. Wilfried** and while having the dinner, **Mr. Ginikana** promised to sell the car to **Mr. Wilfried** for Rs.2.5 million.

You are required to:

- (a) **Explain** whether there is a valid contract between **Ms. Kalpana** and **Mr. Ginikana**. (05 marks)
- (b) **Explain** whether there is a valid contract between **Ms. Podimenike** and **Mr. Ginikana**. (05 marks)
- (c) **Explain** the legal rights of **Mr. Wilfried**. (05 marks)

(B) A lady mechanical engineer, **Suraksha**, had joined **Sure Insurance Corporation Ltd.** as a professional Motor Assessor as she was found to be suitable to carry out inspections, assessments and investigations connected with motor insurance claims made by the customers to **Sure Insurance Corporation Ltd. Suraksha** joined the **Sure Insurance Corporation Ltd.** on 01st June 2020. According to the contract entered into between parties, **Suraksha** was bound to work for the benefit of **Sure Insurance Corporation Ltd.** If she fails to do so, the company has the ability to terminate the employment. **Suraksha** should report to the office before 9.30 am every day. **Sure Insurance Corporation Ltd.** provided all necessary equipment to assessors and re-imbursed the transport and other relevant expenses with regard to valuations.

Two years later, on 18th June 2022, **Sure Insurance Corporation Ltd.** had terminated the service of **Suraksha**. In this juncture, **Suraksha** argued that she was an employee of the company. However, company said she is an independent contractor.

You are required to:

- (a) **Explain** the difference between an employee and an independent contractor referring to applicable tests. (05 marks)
- (b) **Discuss** whether **Suraksha** could claim her position as an employee against **Sure**Insurance Corporation Ltd. (05 marks)
