Question 02

Walimuni is the union leader at his workplace. **Walimuni** applied for a life insurance policy at **XYZ Insurance Ltd**. At the medical test, he was asked whether he had consulted a doctor in asthma specialization during the past five years. **Walimuni** answered "no". However, he had gone through with a doctor for asthma and had prescribed two inhalers for regular use. After obtaining the policy, at a huge protest organized by **Walimuni's** trade union, **Walimuni** was badly affected by the resorted tear gas charge and thereby he died due to the severe damage caused to his lungs by the tear gas effect and asthma. From the post-mortem, it was identified that the very course of his dead was asthma on weak lungs.

You are required to:

- (a) **Explain** whether **Walimuni's** wife can claim compensation under the life insurance cover obtained from **XYZ Insurance Ltd.** (06 marks)
- (b) **Explain** two(02) parties of an Insurance Agreement.

Question 03

Rosi joined a private limited company on 01st April 2018 for a salary of Rs.60,000/-. She is entitled to Employees' Trust Fund (ETF) and Employees' Provident Fund (EPF) as an employee of the company. She has submitted her letter of resignation with effect from 30th April 2023 to migrate for permanent residency of another country. Her last month salary was Rs.200,000/-.

You are required to:

- (a) **Calculate, Rosi's** gratuity entitlement at the time of resignation. (04 marks)
- (b) **Explain, Rosi** on her right to withdrawal of EPF. (03 marks)
- (c) **State** three(03) main functions of the ETF Act No. 46 of 1980. (03 marks) (Total 10 marks)

Question 04

Suresh wrote a book titled "Hoda Yaluwo" in 2019 and obtained the copyright for the book. He had given the authorization to **Nimal** to translate this book. However, **Suresh** passed away in 2020. After finishing the translation, **Nimal** published this book as his book in different title. **Suresh's** wife is planning to take legal action against **Nimal**.

You are required to:

- (a) **Explain** the legal rights of **Suresh's wife** under the copyright law in Sri Lanka. (06 marks)
- (b) **State** two(02) objectives of the Intellectual Property Act No. 36 of 2003. (04 marks) (Total 10 marks)

"Partnership formation is likely the most frequently litigated question in all of the business law, but it has received little modern theoretical attention. As a result, the routine analysis of partnership-formation problems is ruled by relatively unexamined conceptualistic assumptions."

Question 06

Sarath is an owner of a poultry farm and egg wholesale business. He has authorized **Kapila** to manage and operate his business at a profit. As a part of their contract document, **Kapila** was instructed not to sell eggs below the price of Rs.55/- each under any circumstances. Nothing was mentioned regarding emergency chicken feed supplies in the contract document. However, there was a sudden shortage of chicken feed stocks and **Kapila** bought chicken feed from **Mohamed** on credit. Meantime, **Kapila** sold 1,000 eggs to **Raja** at the price of Rs.52/- each and **Raja** subsequently realized that most of the eggs were not in good quality.

You are required to:

- (a) **Explain** the nature of the agency relationship between **Sarath** and **Kapila**. (03 marks)
- (b) **Explain** whether **Sarath** is liable to pay **Mohamed** for the chicken feed bought by **Kapila** on credit. (04 marks)
- (c) **Explain** whether **Raja** could claim compensation from **Sarath**. (03 marks) (Total 10 marks)

Question 07

(A) **Apsarie** runs a business named **AAA Ltd.** in her hometown, Badulla. Her company is producing a traditional beauty cream, named "Turmerica" using a native Sri Lankan Turmeric which can be used as a foundation body application. On 08th January, **Apsarie** called a Turmeric supplier, **Kahathuduwa** who lives in Horana, and offered him to supply 500kg of Sri Lankan Turmeric at Rs.5,000/- per kilogram and wanted him to accept or reject the offer by a postal letter addressed to **Apsarie's** office in Badulla. On the morning of 10th January, **Kahathuduwa** posted a letter to **Apsarie** stating that he is ready to supply the said quantity for the stated price. This letter reached **Apsarie's** office on 13th January. In the meantime **Ali**, another Turmeric supplier, heard about **Apsarie's** offer and decided that he would accept the offer. In the late evening of 10th January, **Ali** met **Apsarie** where she offered the contract to **Ali** to supply 500kg of Turmeric for the price of Rs.4,500/- per kilogram which **Ali** accepted, and he unloaded the requested quantity of Turmeric at **Apsarie's** office. **Apsarie** revealed the contract she entered with **Ali** and rejected **Kahathuduwa's** Turmeric. **Kahathuduwa** now plans to take legal action against **Apsarie**.

Recently, **Apsarie** discovered that the extracts of her product "Turmerica", can be used as a painting colour and she named this by-product as **"Kaha-AAlepa"**. **Apsarie** advertised this by-product in newspapers with the inscription,

"Rs.100,000/- reward will be paid by **Apsarie** to any person who makes claims on the usage of "**Kaha-AAlepa**". Please follow the given instructions"

Sittara-Gurunnanse is a fresco conservation painter who recently won a bid for the conservation of ancient fresco paintings at a temple in Kandy. He bought *Kaha-AAlepa* from **AAA Ltd.** and used it for fresco works at the temple according to the prescribed manner given by **AAA Ltd.** After the colour was applied, within one-week time ancient frescos were completely destroyed.

You are required to:

(a) **Explain** whether **Apsarie's** telephone call made a valid offer to **Kahathuduwa**.

- (b) **Discuss** whether **Kahathuduwa** could take legal action against **Apsarie**. (06 marks)
- (c) **Discuss** whether **Sittara-Gurunnanse** could take a legal action against **Apsarie**. (06 marks)
- (B) The government decided to import eggs as a solution to the unusual egg price hike prevailing in Sri Lanka. **Uttara-Bittara Ltd. (UB),** is a well-known eggs wholesale company in Sri Lanka. **UB** has received an order from **K-Super,** a super market to supply imported eggs. Before placing the order, the Manager of **K-Super** visited **UB's** warehouse and inspected a sample of the imported eggs. Then **UB** supplied a bulk of 10,000 eggs from their own stocks to **K-Super**, described as "imported from India". After delivering the agreed lot of 10,000 eggs, the store-keeper of the **K-Super** discovered that only 6,000 eggs were similar to the samples shown, and the rest of the bulk eggs were not imported from India.

K-Super is now planning to take legal action for damages against **UB**.
