

Question 04

In 2010, **Professor Gamini** died and consequently, **Malini** continued her husband's drama works. In 2015, the "Bari-Nana" drama was selected as a part of G.C.E. (A/L)'s Sinhala subject by the Department of Education. One of the famous Sinhala tuition masters, **Anil** printed the script of this drama as a book, "Beri-Nena" and sold the same to his tuition students at a considerable price.

Malani took legal action against Anil on publishing this book.

Question 07

(A) Savarika is a habitual traveler who has travelled more than 25 countries in the World. Therefore, her Passport is a remarkable one of its kind. Unfortunately, Savarika's house was robbed last Friday night. The robbers have stolen many items, including Savarika's Passport. While logging a police complaint, Savarika decided to put up a notice on her home gate offering a reward of Rs.100,000/- for whoever finds and returns her passport. She did this as she is planning to migrate UK in which her passport has a tremendous value in the visa application process. **Pirisindu** is a young cleaner at the local supermarket, **C-Gills Super**. As he was emptying the store bins, a passport was found from a bin. **Pirisindu** noticed that name "**Ms. Christopherge Savarika Columbus**" appears on the detail page of the Passport. **Pirisindu** knows that **Savarika**, is a regular customer of the **C-Gills Super**. On the same day at noon, when **Savarika** visited the supermarket, **Pirisindu** handed over the passport to **Savarika**. In the evening, on his way back home, when he passed **Savarika**'s house, **Pirisindu** saw the notice on the gate. He claimed the reward of Rs.100,000/- which **Savarika** refused. **Pirisindu** is now going to sue against **Savarika**.

You are required to:

- (a) **Explain** whether **Pirisindu** could take a legal action against **Savarika**. (06 marks)
- (b) **Explain** four(04) requirements of a valid Contract. (08 marks)
- (B) (a) Silva joined Lanka Air Ltd., the national air carrier, as a member of its pet control unit, on the 01st of February 2022. As a member of Lanka Air Ltd.'s pet control unit, he was found to be suitable for carrying out pet inspections, assessments, investigations, and controlling pets such as "Rats" in airplanes. According to the contract entered between parties, Silva is bound to work for the benefit of Lanka Air Ltd. If he fails to do so, the company can terminate his employment. Silva should report to the office before 9.30 am every day. Lanka Air Ltd. provided all necessary pet control equipment and other relevant expenses for the above-mentioned job description.

Two years later, on 29th February 2024 **Lanka Air Ltd.** terminated the services of the **Silva**. In this occasion, **Silva** argued that he was an employee of the company. However, **Lanka Air Ltd** said he is an independent contractor.
