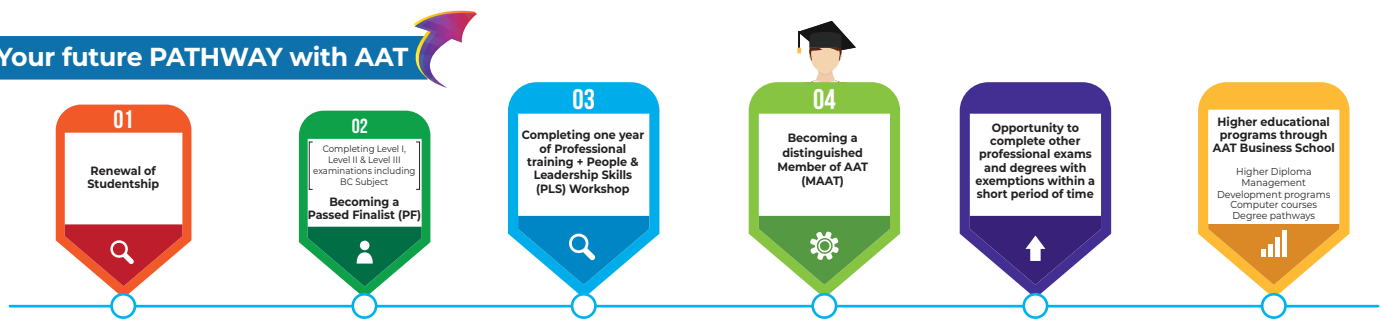

RENEWAL PROCESS

To renew your studentship, You only need to **make the payment correctly as mentioned above.**
