#### Chapter 3 - Business Writing Skills

According to the information depicted in the graph there is a comparison of monthly tourist arrivals between the year 2022 and year 2023 from the months from January to September. There is a 93.1% increase when comparing tourist arrivals in the first nine months.

The most significant increase can be seen in the month of August with a 261.2% increase in tourist arrivals between the years.

The lowest increase from 2022 to 2023 was recorded in the month of February where there were 96,507 tourist arrivals in 2022 and 107,639 tourist arrivals in 2023 with a minor increment of 11.5%.

In 2022 the highest tourist arrivals was in the month of March with 106,500 tourist arrivals and in 2023 the highest tourist arrivals was in the month of July with 143,039 tourist arrivals. In 2022 the lowest volume of tourist arrivals was recorded in the month of September whereas in 2023 the lowest volume of tourist arrivals was in the month of May.
